4	GENERAL ORDER RE: EARLY TERMINATION OF PROBATION
5	PURSUANT TO ASSEMBLY BILL 1950
6	
7	Effective January 1, 2021, Assembly Bill No. 1950 (2019-2020 Reg. Sess.)(AB1950) has amended Penal Code sections 1203a and 1203.1. The amendments retroactively modify the
8	probation terms for certain offenses. In implementing the amendments, this Court hereby FINDS AND ORDERS AS FOLLOWS:
9	
10	1. <u>Felonies</u> - AB1950 has shortened the probation terms for most felony offenses to two years. In relevant part, Penal Code section 1203.1, subdivision (a), with certain
11	exceptions, provides, "The courtin the order granting probation, may suspend the imposing or the execution of the sentence and may direct that the suspension may
12	continue for a period of time not exceeding two years" Previously, the maximum term
13	of probation for a felony offense could be for a period of time not exceeding the maximum possible term of the sentence. If the maximum possible term of the sentence
14	was five years or less, the period of probation could be up to five years.a. By operation of law, the shortening of the probation terms is retroactive.
15	b. Exclusions -Pursuant to Penal Code section 1203.1, subdivision (m), the two-year
16	limit on the term of probation shall not apply to: i. Any violent felony listed in Penal Code section 667.5, subdivision (c).
17	(See Appendix II for a complete list of excluded violent offenses and their maximum probation terms.)
18	ii. Any offense that includes specific probation lengths within its provisions. (See Appendix I for the complete list of crimes with specified minimum
19	terms of probation.)
20	iii. Any felony conviction of Penal Code section 487, subdivision (b)(3), if the total value of the property taken exceeds \$25,000. In this case, the
21	maximum term of probation is three years.
22	iv. Any felony conviction of Penal Code section 503, if the total value of the property taken exceeds \$25,000. In this case, the maximum term of
23	probation is three years.v. Any felony conviction of Penal Code section 532a, if the total value of the
24	property taken exceeds \$25,000. In this case, the maximum term of probation is three years.
25	2. <u>Misdemeanors</u> – AB1950 has shortened the probation terms for most misdemeanor
26	offenses to one year. In relevant part, Penal Code section 1203a subdivision (a) states, "The court may suspend the imposition or execution of the sentence and make and
27	enforce the terms of probation for a period not to exceed one year." Previously, the
28	maximum term of probation for a misdemeanor offense was three years, or if the term of

1	imprisonment on a particular crime was greater than three years, the probation term was up to the maximum term of imprisonment.
2	 a. By operation of law, the shortening of the probations terms is retroactive. b. <u>Exclusions</u>-Per section 1203a, subdivision (b), "The one-year probation limit in
3	subdivision (a) shall not apply to any offense that includes specific probation
4	lengths within its provisions." (See Appendix I for the complete list of crimes with specified minimum terms of probation.)
5	3. <u>Exclusion for Crimes Involving Domestic Violence</u> -In relevant part, pursuant to Penal Code section 1203.097, subdivision (a), "If a person is granted probation for a crime in
6	which the victim is a person defined in Section 6211 of the Family Code, the terms of
7	probation shall include[a] minimum period of probation of 36 months" Thus, a probationer is excluded from the retroactive shortening of probation if the probationer's
8	victim is a person defined in Family Code section 6211, even if the probationer was convicted of an offense that generally carries a two-year probationary term. For example,
9	probation for a violation of Penal Code section 245, subdivision (a)(4) is two years.
10	However, if the victim is a person included in Family Code section 6211, the minimum probation term is three years, and the maximum probation term is four years.
11	4. Determination Procedure - By operation of law, the new requirements of AB1950 have
12	amended existing terms of probation in accordance with the new limits for all included crimes, without the need of the court to specifically order the modified terms. The Court
13	orders the Probation Department to compile a list of cases under their jurisdiction and/or supervision that meet the criteria set forth in AB1950. After compiling the list, the
14	Probation Department is to provide the list to the District Attorney's Office for an
15	opportunity to review eligibility for termination. If the District Attorney's Office agrees probation has expired pursuant to AB1950, a stipulation signed by the District Attorney's
16	Office shall be filed with the Court and a copy served on the Probation Department and Defense Counsel. If the District Attorney's Office challenges the Probation Department's
17	determination of termination eligibility, Probation and Defense Counsel will be properly
18	noticed, and Defense Counsel will calendar the matter with the Court for determination of eligibility if necessary.
19	5. <u>Revoked Probation or Warrants</u> - Defendants whose probation has been revoked and/or
20	have outstanding warrants are not eligible for the procedure contained in this Order.
21	THIS ORDER IS EFFECTIVE IMMEDIATELY.
