Third Accounting:

- 2. The Assets at the end of the Accounting period reflect a \$45,000.00 increase due to an improper gain attributed to the value of the decedent's real property. The accounting should reflect the "carry-value" of the real property and should not have been adjusted to reflect the current market value as the real property was not sold during the accounting period. *Newly noted for the 10/17/25 hearing
- 3. Did the conservatorship received the \$75,000 annuity payment that was to be paid on March 12, 2011? *Newly noted for the 10/17/25 hearing
- 4. The accounting reflects: *Items below addressed in the Declaration filed on 5/20/25 that is subject to the Court's decision.
 - a. Numerous disbursements made by check to unknown payees for unknown reasons.
 - b. Numerous overdraft charges
 - c. Numerous and significant amounts of cash withdrawals by the conservator for gambling purposes.
 - d. No receipts reflected for the Wells Fargo Court Blocked Savings Account for April 30, 2009 through April 30, 2020. Accounting reflects "Statement not Provided" with no incurred bank interest for this period-of-time.
