Probate Notes

Probate Notes for future calendars are available from the time they are created until the morning of the scheduled hearing. The Probate Examiner's Notes typically will be posted 5 days prior to the hearing. If you are filing documents to cure a technical defect, documents should be filed a minimum of 2 court days prior to the hearing. Documents filed late will not be reviewed except on the date of the hearing at the Judge's discretion and could result in a continuance of your case.

Parties intending to appear in Court regarding their hearing must notify all other parties and call (209) 725-4111 to notify the Court of such intent by 4:00 pm on the day before the hearing.

THIS CASE IS SET FOR HEARING ON:

Continued from 04/20/26 for Petition To Determine Succession To Primary Residence.

THE CONTINUING ISSUES AND/OR DEFICIENCIES IN THE PAPERS ARE NOTED:

1. No proof that notice of the petition was delivered to each heir and devisee within five business days of filing the petition. Probate Code §13151(b).
2. No Inventory and Appraisal of the real property is attached to the Petition showing a probate referee performed the appraisal. Probate Code, §§ 8901, 8902, 13152(a)(2); (See paragraph 8 of Petition.)
3. The legal description of the real property shown on the "Grant Deed" in the Supplemental Declaration regarding Exhibit C, filed 4/9/2026, is different than the legal description in the Petition. (See Attachment 11 of Petition.)
4. Clarification whether language on "Grant Deed" stating "*To Sever The Joint Tenancy*" makes Decedent's property separate, subject to intestate shares to both surviving spouse and to Decedent's children. Probate Code §6401(c)(3)(A);
5. Any property or interest at the time of the Decedent's death and held by the Decedent as a joint tenant or was held by the Decedent and passed to the Decedent's surviving spouse by law is excluded from any Petition To Determine Succession To Primary Residence. Probate Code §13050(a)(1).
6. Clarification whether the real property described in this case was part of any pleading or proceeding in County of Stanislaus Superior Court Case No. 2200698, named "In re The Tarris Philyaw Living Under Agreement Dated October 24, 2001," hereinafter "Trust Case." See Exhibit E attached to Petition.
7. The County of Stanislaus Superior Court is the court presiding over judicial proceedings regarding the Trust Case. Probate Code §871(e); (See Ex. E.)
8. The County of Stanislaus Superior Court appears to retain jurisdiction over the Trust Case. Probate Code §§17301, 871(e).
9. No Proof of Service of Notice of Hearing on file. Probate Code §13153.
10. No proposed Order Determining Succession To Primary Residence submitted to the Court. Probate Code §13154.
11. In pro per Petitioner is a non-attorney Trustee representing the Tarris Philyaw 2001 Revocable Living Trust in this Court proceeding and is representing and affecting the interests of the beneficiaries and therefore appears to be engaged in the unauthorized practice of law. Bus. & Prof. Code §6125.
