If you are filing documents to cure a technical defect, documents should be filed a minimum of 2 court days prior to the hearing. Documents filed late will not be reviewed except on the date of the hearing at the Judge's discretion and could result in a continuance of your case.

Parties intending to appear in Court regarding their hearing must notify all other parties and call (209) 725-4111 to notify the Court of such intent by 4:00 pm on the day before the hearing.

7. Proposed Order to Deposit Funds in Blocked Account is missing representative capacity of Petitioner. (See Paragraph 1.)
8. Proposed Order to Deposit Funds in Blocked Account is missing Minor's Date of Birth. (See Paragraph 5.b.)
