Pib Koj Txoj Kev Sib Nrauj, Sib Cais Nyob Raws Kev Cai, los sis Thim Daim Ntawv Sib Yuav Tshooj #1

Pob ntawv no muaj:

- Cov txheej xwm thiab lus qhia txog qhov kawg ntawm kev ua txij nkawm thiab tus txheej txheem hauv tsev hais plaub
- Daim ntawv txheej xwm nrog rau txhua kauj ruam ntawm cov txheej txheem
- Cov ntawv rau koj sau pib rooj plaub
- Cov ntawv tsis tau sau rau koj siv (muab raws kev raws cai) rau koj tus txij nkawm los sis tus hlub

Cov kauj ruam keev siv yog:

1. Sau koj cov ntawv.
2. Xa koj cov ntawv mus rau tsev hais plaub.
3. Kom lwm tus uas muaj hnuv nyoog 18 xyoo rov sauv (txhob yog koj) muab cov ntawv rau koj tus txij nkawm los sis tus hlub. Qhov no hu ua "service."
4. Tos seb koj tus txij nkawm los sis tus hlub puas teb tuaj.
5. Ua kom koj rooj plaub tiav hlo, tsis hais los ntawm koj tug kheej, los ntawm kev sib khom haum, los sis los ntawm kev sib hais kom muaj yeej muaj swb hauv tsev hais plaub tim ntsej tim muag ntawm tus neeg txiav txim.
