Demurrer to Plaintiff's Complaint

Defendant's demurrer to Plaintiff's complaint is SUSTAINED WITH LEAVE TO AMEND on the basis of failure to state facts sufficient to constitute a cause of action.

The complaint does not meet the statutory requirements of Code of Civil Procedure section 761.020 subds. (a), (d).

Further, the complaint alleges that on or about January 13, 2023, Plaintiff redeemed and reinstated the vehicle by making a payment of \$3,721.27 (Complaint ¶ 7). The complaint also alleges that Defendant has not resumed collection activity (Complaint ¶ 10). However, Exhibit B, attached to Plaintiff's complaint shows that Plaintiff made at least four (4) additional payments after January 13, 2023.

The additional payments after January 13, 2023, directly contradict the allegation that the payment of \$3,721.27 redeemed and reinstated the vehicle. In addition, Exhibit B shows an outstanding principal balance of \$25,675.09. This fact also directly contradicts the allegation that Defendant has no current legal interest in the subject vehicle.

"[W]here facts appearing in attached exhibits or judicially noticed documents contradict, or are inconsistent with, the complaint's allegations, we must rely on the facts in the exhibits and judicially noticed documents." (*Jimenez vs. Mrs. Gooch's Natural Foods Markets, Inc.* (2023) 95 Cal.App.5th 645, 653.)

Plaintiff is to file an amended complaint within ten (10) days of this court's order.
