The Court notes that none of the three cases cited in the memorandum of points and authorities by Auto Resources support its argument that a party in default in one action may still participate in an interpleader proceeding. Nevertheless, no opposition has been filed citing legal authority that a defaulted party is barred from intervening in a cross-complaint for interpleader. Auto Resources, Inc. shall file the proposed verified answer to Western Surety Company's verified complaint in intervention forthwith.
