Motion for Summary Judgment or in the Alternative Summary Adjudication

The unopposed motion for summary judgment by plaintiff U.S. Bank National Association is GRANTED. Upon consideration of all the evidence set forth in the moving papers, particularly the declaration of Legal Specialist Timothy Harper and the attached business records, the Court finds that there is no triable issue of material fact and plaintiff is entitled to judgment as a matter of law. Plaintiff filed a separate statement of undisputed material facts, supported by admissible evidence, containing Facts 1-9 and Facts 10-18 that establish each required element of the common count causes of action for open book account and account stated. This shifts the burden to defendant Yvette Smith to show the existence of one or more triable issues of material fact. (Code Civ. Proc., § 437c, subd. (p)(1).) By not filing any opposition, defendant has failed to meet her burden on this motion.

In light of the Court's ruling on the motion for summary judgment, it is unnecessary for the Court to rule on plaintiff's alternative motion for summary adjudication.

The Court will sign the proposed order and proposed judgment lodged with the moving papers on February 21, 2025.
