Motion for Protective Order Prohibiting the Deposition of Sheriff Vern Warnke pursuant to the Apex Doctrine.

This Motion for Motion for Protective Order Prohibiting the Deposition of Sheriff Vern Warnke pursuant to the Apex Doctrine is being heard on shortening time pursuant to an order of this Court issued on July 3, 2024.

As a general rule, heads of agencies and other top officials are not subjected to depositions absent compelling reasons. (*Westly v. Superior Court* (2004) 125 Cal.App.4th 907, 911.) The doctrine applies to both named defendants as well as third parties. (*Id.* at 910.) Courts have applied the doctrine to many types of positions including constitutional officers, board members, and agency heads. (*Contractors' State License Bd. v. Superior Court* (2018) 23 Cal.App.5th 125, 131.) Only when an agency head or other official has direct personal factual information pertaining to the material issues in the case and the deposing party shows that the information is unavailable through any other

source, can their depositions be taken. (*Westly v. Superior Court* (2004) 125 Cal.App.4th 907, 910.) Absent a showing that an apex deponent has unique or superior personal knowledge. An apex deponent may not be deposed before less intrusive discovery methods have been exhausted. (*Liberty Mutual Ins. Co. V. Superior Court* (1992) 10 Cal.App.4th 1282, 1288.) When a Motion for Protective Order has been filed, the party seeking to depose a high government official, the burden is on the deposing party to show that compelling reasons exist for permitting the deposition. (*Liberty Mutual Ins. Co. v. Superior Court* (1992) 10 Cal.App.4th 1282, 1289.) An exception will be made only when the deposing party makes two showings: (1) The deposing party must show that the government official "has direct personal factual information pertaining to material issues in the action..." (*Westly v. Superior Court* (2004) 125 Cal.App.4th 907, 911); and (2) the deposing party must also show "the information to be gained from the deposition is not available through any other source. (*Ibid.*)

This Court finds, as a matter of law, that Sheriff Vern Warnke has been sued in his official capacity as Sheriff of the County of Merced. (Second Amended Complaint Paragraph 11,12), that he is the "agency head" for the Merced County Sheriff's Office, and that in accordance with. (*Contractors' State License Bd. V. Superior Court* (2018) 23 Cal.App.5th 125, 131, the apex doctrine applies to the Notice of his Deposition and this instant Motion for Protective Order properly raises his objection to the taking of his deposition.

Since this matter is being heard on shortened time, the court has not as yet received briefing from the Plaintiff on whether: (1) The deposing party must show that the government official "has direct personal factual information pertaining to material issues in the action..." (*Westly v. Superior Court* (2004) 125 Cal.App.4th 907, 911); and (2) the deposing party must also show "the information to be gained from the deposition is not available through any other source. (*Ibid.*) Absent the briefing showing satisfaction of these two burdens, the motion for protective order will be denied.
