All Requests for Judicial Notice are GRANTED. The Motion by Defendant Peninsula Bay Trust Company to Change Venue to San Mateo County is GRANTED. This Court finds that the instant action involves the internal operations of a trust and that it is undisputed that the Trust is being administered in San Mateo County by a Trustee located in San Mateo pursuant to an agreement of the parties herein appointing a successor trustee, where matters related to the claims herein are currently being litigated.
