The Demurrer by Defendant Classic Yam, Inc. to Plaintiffs' Complaint and the First through Ninth Causes of Action therein is OVERRULED. The Court has reviewed the Class Action Complaint and finds that while the bulk of the allegations are general, they allege the ultimate facts necessary to establish each cause of action. (See *C.A. v. William S. Hart Union High School District* (2012) 53 Cal.4th 861, 872.) The allegations are

sufficient to place Defendants on notice of the claims being made and the theorires of liability on which those claims are based with sufficient detail to enable the preparation of a defense. (*Okun v. Superior Court* (1981) 29 Cal.3d 442, 458.) General Pleadings are more common in Class Actions such as the instant case because the actual Plaintiffs are merely representatives of the claims being asserted on behalf of all class members and the specifics of the class representative claims are more appropriately addressed in a motion for class certification than on demurrer. Accordingly, The Demurrer by Defendant Classic Yam, Inc. to Plaintiffs' Complaint and the First through Ninth Causes of Action therein is OVERRULED.
