Demurrer to Unlawful Detainer Complaint

The Complaint concedes that the tenancy was subject to the Tenant Protection Act of 2019 and the allegations of the complaint confirm that the tenancy was in existence for more than 12 months and was not subject to an exemption from the Tenant Protection Act of 2019. The complaint alleges that the Tenancy was terminate for both at-fault just cause and no-fault just cause, alleges that \$1,500 in rent was waived, but the 60 day notice does not state a reason that the termination qualifies as at-fault just cause, and does not mention the rent waiver alleged in the complaint. Since the 60 day notice cannot be amended, the Demurrer is Sustained Without leave to amend.
