Motion to Dismiss Plaintiff's Complaint Action for Failure to Prosecute Pursuant to C.C.P. 583.360

Defendants' unopposed motion to dismiss Plaintiff's complaint for failure to prosecute is GRANTED.

Code of Civil Procedure section 583.310 states, "An action shall be brought to trial within five years after the action is commenced against the defendant."

Code of Civil Procedure section 583.360 subd. (a) states, "An action shall be dismissed by the court on its own motion or on motion of the defendant, after notice to the parties, if the action is not brought to trial within the time prescribed in this article."

Plaintiff's complaint was filed on May 23, 2019. Greater than 5 years has elapsed since this matter was commenced against Defendants.

Absent an agreement extending the time within to bring this action to trial or tolling of the time, dismissal is mandatory. See Code Civ. Proc. § 583.360 subd. (b).

Accordingly, Plaintiff's action against defendants Maher Zada and Aida Zada is DISMISSED WITH PREJUDICE.

All future court dates are vacated, as there are no defendants remaining in the case.

Motion to Compel Answers to Interrogatories & Request for Statement of Damages; & for Sanctions

Defendant's unopposed motion to compel responses to Form Interrogatories, Set One, is GRANTED.

Plaintiff has failed to provide timely responses to Form Interrogatories, Set One.

Objections are waived.

Plaintiff shall serve verified responses, without objections, within fifteen (15) days of the date of service of this order.

Defendant's notice and motion stated Defendant would move for an order compelling Plaintiff to provide a statement of damages. However, the court finds it reasonable to reduce the requested amount to \$750.

Plaintiff is ordered to pay \$750 within thirty (30) days of this court's order.
