Motion for Order Approving Class Notice and Appointing KCC Class Action Services, LCC as Class Administrator .

The Motion for Order Approving Class Notice and Appointing KCC Class Action Services, LCC as Class Administrator is GRANTED. The objections by Defendants UC Construction Co. and Stonefield, Home, Inc., by Cross-Defendants Simpson Strong-Tie, Inc. and joinders thereto are OVERRULED.

This Court finds that Class Notice Meets Cal Rules of Court Rule 3.766(b) by clearly and unambiguously providing class members with the option to exclude themselves. The Notice states: "If you want, the Court will exclude you from this action so long as the request form below is completed and postmarked on or before February 23, 2024" and provides an "Opt-Out Form" which members who wish to opt out may utilize.

This Court finds that the Class Representatives Exhausted the Statutory Prequisities to Bring Suit as required by law for standing to Assert the Class Claims. This Court finds that Plaintiffs have satisfied analogous case law, *Friends of Mammoth* (1972) 8 Cal.3d 247, 275, in that there has been sufficient prelitigation resolution to give defendants an opportunity to act and render litigation unnecessary. This Court finds that UC Construction Co is propertly named in the Class Notice.

This Court finds the identification of Simpson Staps at issue is adequate for purposes of Class Notice. Defendant's reliance on *Duran v. Obesity Research Inst, LLC* (2016) 1 Cal.App.5<sup>th</sup> 635 relating the adequacy of a notice of class settlement is inapplicable to the instant notice.
