Motion for Judgment on the Pleadings by Foster Poultry Farms LLC (erroneously sued as Foster Farms LLC)

The Motion for Judgment on the Pleadings is GRANTED WITH LEAVE TO AMEND. All Requests for Judicial Notice are GRANTED. Any Amended Complaint will be filed by April 18, 2025.

Plaintiff concedes that "Plaintiffs did not formally amend [the complaint] on or after August 1, 2021, to allege that the statutory deadline for the LWDA to complete is investigation of the claims had expired without the issuance of a finding." (Opposition at Page 2:4-9), and there is no dispute that the Complaint contains an ambiguity in Paragraphs 13, 62, and 64 stating that the Plaintiff will seek leave to amend to allege a claim with respect to § 2802 penalties, amendments that were never in fact made. On the other hand there is no dispute that the parties have been acting with an understanding that a § 2802 claim was pending. (See e.g. Joint Stipulation to Dismiss filed February 10, 2025 at Page 3:11-12 ["WHEREAS this action seeks civil penalties under PAGA for alleged violations of: (1) California Labor Code § 2802..."].)

It appears to the Court that the failure to amend was probably due to mistake, not a deliberate litigation strategy, and therefore, if there is any actual prejudice to Defendants arising from the granting of the proposed amendment at this stage in the proceedings, such prejudice is best dealt with directly pursuant to CCP § 473(a) ["...court may in furtherance of justice, and on any terms as may be proper, allow any party to amend any pleading..."].) Accordingly, the Motion for Judgment on the Pleadings is GRANTED WITH LEAVE TO AMEND. Any Amended Complaint will be filed by April 18, 2025.

Motion to Compel Deposition of Person Most Knowledgeable

In light of the above ruling Granting the Motion for Judgment on the Pleadings with Leave to Amend, the Court determines that the Motion to Compel is not moot.

The Motion to Compel Deposition of Person Most Knowledgeable. The deposition will occur on or before April 30, 2025 unless the parties agree to a different date in writing. The parties are ordered to meet and confer on all issues relating to any allege prejudice resulting from the amended pleadings and any concerns concerning the PMK Depositions. The reciprocal requests for sanctions are denied without prejudice to renewal in the event the parties are unable to resolve all issues regarding the amended pleading and the PMK Deposition.
