The Motion to Dismiss pursuant to CCP § 583.410-583.430 by Defendant OneSource Virtual, Inc. on the grounds of failure to comply with contractual forum selection clause, and forum non convenes is DENIED.

The interpretation of the contract containing the forum selection clause at issue is Delaware Law. Delaware law provides that a clause providing that a certain state "shall" have jurisdiction is mandatory. (Ashall Homes LTD. V. ROK Ent. Grp., Inc. (Del. Ch. 2010) 992 A.2d 1239, 1250-1251.) The instant forum selection clause, paragraph 8.2 of the subject contract states: "As a further inducement [OneSource] [Foster Farms] agrees it will irrevocably submit itself to the personal and subject matter jurisdiction of the State and Federal Courts located in New Castle County, Delaware, and will not object to such venue on the theory of forum non conveniens or other legal theory." While OneSource concedes that the word "shall" does not appear in the forum selection portion of the paragraph 8.2 (The word "shall" does appear in the uncontested choice of law section of that paragraph), OneSource argues that the language concerning the Forum Selection Clause is equivalent to "shall." Applying Delaware law, this Court disagrees. There is nothing in the Forum Selection portion of Paragraph 8.2 providing that Delaware State and Federal courts "shall" have "exclusive jurisdiction." Accordingly this Court finds that the Forum Selection Clause in paragraph 8.2 is permissive, not mandatory, and that while Foster Farms may have breached the contract by bringing an action in California instead of Delaware, the clause does not deprive the California Courts of jurisdiction.

Furthermore, this Court finds that Defendant OneSource has failed to establish its initial burden of demonstrating that California is a forum non conveniens vis a vis Delaware.

There are no witnesses in Delaware and there are numerous witnesses in California. Accordingly, the Motion to Dismiss pursuant to CCP § 583.410-583.430 by Defendant OneSource Virtual, Inc. on the grounds of failure to comply with contractual forum selection clause, and forum non convenes is DENIED.

Demurrer Pursuant to CCP § 430.10(e) for Failure to State a Cause of Action

The Demurrer Pursuant to CCP § 430.10(e) for Failure to State a Cause of Action is OVERRULED with respect to the First Cause of Action for Breach of Contract and the Fourth Cause of Action for Unfair Competition but is SUSTAINED WITH LEAVE TO AMEND as to the Second Cause of Action for Fraud in the Inducement and the Third Cause of Action for Negligent Misrepresentation. Both California and Delaware law required fraud to be alleged with specificity. While the complaint is fairly specific as to the content of the alleged untrue statements, there is nothing about when and how the statements were communicated and no allegations as to who made the alleged untrue statements. Accordingly the Demurrer is SUSTAINED WITH LEAVE TO AMEND as to the Second Cause of Action for Fraud in the Inducement and the Third Cause of Action for Negligent Misrepresentation.
