Demurrer by Cross-Defendant Foster Poultry Farms to Cross-Complaint's First Through Ninth Causes of Action

When ruling on a demurrer, the court can consider only facts alleged in the complaint and matters of which the court can take judicial notice. (*Blank v. Kirwan* (1985) 39 Cal.3d 311, 318; Code of Civ. Proc. § 430.30, subd. (a).) As a general rule, no other extrinsic

evidence may be considered on a demurrer. (See, e.g., *Ion Equip. Corp. V. Nelson* (1980) 110 Cal.App.3d 868, 881.)

Each of the cross-complaint's nine causes of action that are the subject of the instant demurrer are based on a Contract Manufacturing Agreement ("CMA") between Pet Treat Holdings and Foster Poultry Farms, LLC. While Foster Poultry Farms, LLC asserts that the court may consider the CMA in ruling on the demurrer and that the terms of the CMA are dispositive, the declaration of Sarah E. Balkissoon filed on May 12, 2025, in support of the demurrer does not attach a copy of the CMA or include any language authenticating a copy of the CMA, and the redacted copy of the CMA attached to the demurrer itself is not supported by any declaration that the court can locate.

The complaint, first amended complaint, and the cross-complaint all refer to the CMA, and none disputes that the parties entered into the CMA. However, none of these pleadings includes a complete copy of the CMA or alleges the terms of the entire agreement. Therefore, once the complete contract is provided, the CMA may be properly the subject of judicial notice pursuant to Evidence Code § 452, subd. (g), or by stipulation of the parties. If a dispute exists as to the terms of the CMA, the questions raised by demurrer regarding what constituted a breach are not properly the subject of demurrer, but rather are issues to be resolved by way of motion for summary judgment.

Accordingly, the matter is CONTINUED TO MONDAY, JUNE 23, 2025, and Foster Poultry Farms, LLC is ORDERED TO SUBMIT, BY JUNE 23, 2025, a revised declaration authenticating a complete, unredacted copy of the CMA upon which the demurrer relies, along with an appropriate request for judicial notice of the terms of such contract.
